## 參、申請資格

### Eligibility

入學資格須符合教育部《外國學生來臺就學辦法》、《僑生回國就學及輔導辦法》及《香港澳門居民來臺就學辦法》之規定。申請者須為國外大學畢業生。

You may apply if you meet the requirements specified in the MOE Regulations Regarding International Students Undertaking Studies in Taiwan, Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan, and Residents of Hong Kong and Macao Undertaking Studies in Taiwan. Applicants must be graduates from foreign universities.

學歷資格須符合教育部《外國學生來臺就學辦法》、《大學辦理國外學歷採認辦法》、《香港澳門學歷檢覈及採認辦法》、《大陸地區學歷採認辦法》及《入學大學同等學力認定標準》之規定。

You may apply if you meet the requirements specified in the MOE Regulations Regarding International Students Undertaking Studies in Taiwan, Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education, Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao, Regulations Governing the Recognition of Educational Qualifications from Mainland China, and Standards for Recognition of Equivalent Educational Levels for University Admission.

### 二、申請費 Application Fee

1. 國內匯款者，每一申請件新台幣1,600元；海外匯款者，每一申請件美金65元。申請費一經繳納，恕不退還。

The application fee is NT\$1,600 per program if you are applying from within Taiwan. If you are applying from a location overseas, please pay an application fee of US\$65 per program. Please note that application fees will not be refunded.

2. 請自申請系統下載專屬匯款資訊。請勿連同其他申請者費用一起匯款，以免資料無法核對。

Download the remittance information for your exclusive account from the online application system. Please only pay your own application fee(s). Do not combine your payments with other applicants because the university may not be able to confirm that you paid.

3. 申請費收據須於申請期間內上傳至申請系統。

Upload a scanned copy of your payment receipt to the system by the application deadline.

### 三、申請文件 Required Documents

- ◎ 若有疑義，本校得要求申請者繳交經我國駐外機構驗證之文件，並經駐外機構查證後，方核發入學許可。

If there are any points of uncertainty, the University may request that the documents be authenticated by an overseas representative office of the Republic of China (Taiwan). The University will only issue a Certificate of Admission after successful verification by the representative office.

**1. 最高學歷證件（中、英文以外之語文，應加附經公證之中文或英文譯本）**

The certificate or diploma of your highest degree (A notarized copy of the translation in Chinese or English is necessary if the original document is in a language other than Chinese or English.)

**2. 含排名資訊之歷年成績單（中、英文以外之語文，應加附經公證之中文或英文譯本）**

Complete academic transcripts including ranking information issued by your school for each year of study (A notarized copy of the translation in Chinese or English is necessary if the original transcript is in a language other than Chinese or English.)

- A. 申請期間尚未取得最高學歷證件之應屆畢業生，請繳交由其學校出具之「預計畢業證明書」（中、英文以外之語文，應加附經公證之中文或英文譯本）。

Graduating students must submit the Certificate of Expected Graduation issued by their school if they have not received their diploma when making their application (a notarized copy of the translation in Chinese or English is necessary if the original document is in a language other than Chinese or English).

- B. 大陸地區學歷：應依《大陸地區學歷採認辦法》規定辦理。

Academic credentials earned in mainland China should be handled in accordance with [Regulations Governing the Recognition of Educational Qualifications from Mainland China](#).

- C. 香港或澳門學歷：應依《香港澳門學歷檢覈及採認辦法》規定辦理。

Academic credentials earned in Hong Kong or Macao should be handled in accordance with [Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao](#).

- D. 其他地區學歷：

(1) 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

(2) 前二目以外之國外地區學歷，應依《大學辦理國外學歷採認辦法》規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

Academic credentials earned in other areas:

1. Academic credentials earned at overseas Taiwan schools or Taiwan schools in mainland China will be regarded as equivalent to credentials earned at domestic schools.

2. Academic credentials other than the two items mentioned above will be handled in accordance with [Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education](#). However, academic credentials earned from a foreign academic institute or university branch established in mainland China must be notarized in mainland China, then examined and verified by an agency established or appointed by the Executive Yuan, or through a private agency commissioned by the Executive Yuan.

**3. 最近三個月內由金融機構開立足夠在臺就學之財力證明（依申請系所之學期學雜費基準，檢附相當於新臺幣十萬至二十萬元之財力證明），或政府、本校或民間機構提供全額獎助學金之證明（中、英文以外之語文，應加附經公證之中文或英文譯本）。財力證明不得由代辦、公司行號或個人開立。**



Financial proof issued within the last 3 months from a banking institution that shows financial sustainability for study in Taiwan (equivalent to NT\$100,000 to NT\$200,000 based on the stipulated tuition and fees of the relevant department or institute to which the student is applying), or proof of full scholarship provided by a government agency, university, college, or private organization (A notarized copy of the translation in Chinese or English is necessary if the original document is in a language other than Chinese or English.) The financial proof must not be issued by agents, companies, or individuals.

**5. 國籍證件（例如：護照）**

Verification of nationality (e.g. a photocopy of your passport)

**6. 切結書（自申請系統下載列印，簽名後再上傳）**

Declaration Form (Download the form from the application system, complete it, and then upload it back to the system.)

**7. 系所指定之其他文件（詳見系所分則）**

Additional documents required by the department or graduate program you are applying to (Please refer to **Individual Requirements**.)

**8. 視個案情況，本校得要求申請者檢附其他證明文件以審核其申請資格與學歷，例如：入出國日期證明書、未設戶籍切結書、香港或澳門永久居留資格證明、父母親中華民國身分證、喪失國籍許可證書等等。**

Depending on the circumstances, the University may request additional documents to review your eligibility and educational background, such as the Certificate of Entry and Exit Dates, Non-Household Registration Declaration Form, a proof of the permanent residence status in Hong Kong or Macao, a document that proves your father or mother has/had R.O.C. nationality status, the Certificate of Nationality Annulment, and so on.

FJCU will send the Certificate of Admission to the mailing address provided in your online application.

3. 入學許可並不保證簽證取得，簽證須由我國外交部領事事務局或駐外機構核給。

The Certificate of Admission does not guarantee the issuance a visa. Visas must be granted by the Bureau of Consular Affairs or by an overseas representative office of the Republic of China (Taiwan).

## 陸、回覆入學意願

### Submitting the Intent to Enroll

#### 一、正取生 Accepted Applicants

1. 於申請系統完成入學意願回覆並獲錄取資格者，本校將寄發入學許可。  
After you have submitted the Intent to Enroll in the application system, the University will mail your Certificate of Admission.
2. 未於期限內線上回覆入學意願者，視為放棄錄取資格。所遺缺額由備取生依規定遞補。  
If you do not submit the Intent to Enroll online by the deadline, FJCU will consider you as voluntarily declining the offer of admission. Your spot will be offered to a student on the waiting list.

#### 二、備取生 Waitlisted Applicants

1. 通知方式：依當時缺額狀況，以電子郵件通知遞補。  
Results will be sent by email according to the status of vacancies.
2. 於申請系統完成入學意願回覆並獲錄取資格者，本校將寄發入學許可。  
After you have submitted the Intent to Enroll in the application system, the University will mail your Certificate of Admission.
3. 未於電子郵件規定期限內線上回覆入學意願書者，視為放棄錄取資格。所遺缺額由其他備取生依規定遞補。  
If you do not submit the Intent to Enroll online by the deadline specified in the email, FJCU will consider you as voluntarily declining the offer of admission. Your spot will be offered to a student on the waiting list.

## 柒、報到

### Check-in at FJCU

1. 完成線上入學意願回覆並獲錄取資格者，請於入學通知書所規定之期間至教務處註冊組（野聲樓 2 樓 YP209 室）辦理報到，逾期未報到者視為放棄錄取資格。

After you have submitted the Intent to Enroll online and have received the status of an admitted student, please go to the Registrar (Room YP209 on the 2<sup>nd</sup> floor of Cardinal Yu Pin Administration Building) at the Office of Academic Affairs to check-in during the registration period as specified on Admission Notice. Students who fail to complete these procedures on time will be regarded as declining admission.

2. 報到應攜帶證件：

Documents required for check-in:

- (1) 經我國駐外機構驗證之最高學歷證明文件影本及驗證後影本各一份（中、英文以外之語文，應加附經公證之中文或英文譯本）。

One photocopy of the certificate or diploma of your highest academic degree. This photocopy must be authenticated by an overseas representative office of the Republic of China (Taiwan). You must also provide one photocopy of the degree after it has been authenticated (a notarized copy of the translation in Chinese or English is necessary if the original document is in a language other than Chinese or English).

- (2) 經我國駐外機構驗證之歷年成績單正本及驗證後影本各一份（中、英文以外之語文，應加附經公證之中文或英文譯本）。

One original copy of complete academic transcripts for each year of study. The original copy must be authenticated by an overseas representative office of the Republic of China (Taiwan). You must also provide one photocopy of the transcripts after they have been authenticated (a notarized copy of the translation in Chinese or English is necessary if the original document is in a language other than Chinese or English).

◎針對以上(1)與(2)之項目，我國未設有駐外機構之國家之學歷查證應由學生向國外畢業學校申請出具修業情形、立案與否及成績單等英文證明，並由學校逕寄輔仁大學教務處註冊組。大陸地區學歷應依《大陸地區學歷採認辦法》規定辦理；香港或澳門學歷應依《香港澳門學歷檢覈及採認辦法》規定辦理。

If there are no overseas representative offices of the Republic of China (Taiwan) in your country to authenticate the diploma and transcripts mentioned in (1) and (2) above, you must apply to the academic institution from which you graduated for the required documents in English. These include: the duration of enrollment, your school's legal status (whether the school is legally registered or not), and your transcripts. Then, please have your former school mail the documents directly to the Registrar at the Office of Academic Affairs. Academic credentials earned in mainland China should be handled in accordance with [Regulations Governing the Recognition of Educational Qualifications from Mainland China](#). Academic credentials earned in Hong Kong or Macao should be handled in accordance with [Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao](#).

- (3) 護照正本及影本一份。

Your passport and one photocopy.

3. 錄取生報到時未能取得學歷證件者，請填寫切結書，並於 2024 年 9 月 27 日前補繳，逾期未繳者取消入學資格。

If you cannot obtain your academic documents in time for check-in, you must fill out the Student Declaration Form and then present all required documents by September 27, 2024. Students will lose admission status if they fail to submit the required documents on time.

4. 本校係採先行受理申請，俟錄取報到後再行審核資格。如發現不符資格時，逕行取消錄取資格。Documents will be reviewed after check-in. If it is found that any documents do not meet requirements, the student will lose admission status.

## 捌、註冊入學

### Registration

1. 請依新生註冊須知規定事項辦理註冊，於入學註冊時，應檢附已於國外投保自入境當日起至少 6 個月效期之醫療及傷害保險，此保險證明應經駐外機構驗證。或提供有效之臺灣全民健康保險卡正本與影本一份。若註冊時未出示投保文件者，必須由本校代辦投保事宜，直至加入臺灣全民健康保險。

Please register in accordance with Guidelines for New Student Registration. You must present proof that you have purchased insurance, which includes both medical coverage and personal accident coverage for a period of at least six months from the date of your arrival in Taiwan. Proof of insurance must be authenticated by an overseas representative office of the Republic of China (Taiwan). If you hold a valid National Health Insurance (NHI) card in Taiwan, you may provide the original and one photocopy instead of purchasing insurance. If you are unable to present proof of insurance when you register, the University will purchase medical insurance on your behalf until you receive National Health Insurance.

2. 保留入學資格：錄取生因病、懷孕、生產、哺育幼兒（三歲以下子女）或其他特別事故，不能於該學期開學時入學者，得檢具相關證明文件向學校申請保留入學資格，展緩入學，惟以 1 年為限，如有特殊情形者，得再申請延長 1 年。申請保留入學資格之新生，應於規定開學日前，繳交入學證明文件，向教務處提出書面申請，不須繳納任何費用。

Retaining Admission: If you are prevented from enrolling for reasons such as illness, pregnancy, childbirth, taking care of a child under 3 years old, or other exceptional circumstances, you may submit relevant documents and apply to retain your admission status for up to one year. Under special circumstances, you may be able to apply to retain admission status for one additional year afterwards. If you would like to retain your admission status, please submit a written application along with your academic documents to the Office of Academic Affairs before the first day of class specified in the academic calendar; no fee is required.

3. 休學、修業年限、畢業條件及應修學分數等學籍相關規定，請參閱本校教務處網站。錄取學生欲申請抵免科目或提高編級者，應依本校學則與輔仁大學學生抵免科目規則辦理。若因學分抵免不足，須延長修業年限，概依規定辦理，不得異議。

For details on leaves of absence, limits on the duration of study, graduation requirements, and required credits, please check out the [website of the Office of Academic Affairs](#). If you wish to apply for credit waivers or apply to a higher level of study should do so in accordance with the regulations stipulated in the [Fu Jen Catholic University Academic Policies](#) and the [Fu Jen Catholic University Regulations for Course Waivers](#). If the number of credits mapped over is insufficient, resulting in a need to extend the period of study to ensure graduation, the student shall comply with the regulations without protest.

4. 外國學生所繳入學證明文件有偽造、假借、塗改等情事，應撤銷錄取資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明；如畢業後始發現者，由本校撤銷其畢業資格並註銷其學位證書。

If it is discovered that an international student forged, fabricated, or altered documents for the application to FJCU, their admission status will be revoked; if the student has already registered, their enrollment status will be cancelled and they will not be issued any academic documents related to their study at FJCU; if the student has graduated, their status as a graduate will be cancelled and their degree will be revoked.

## 玖、實用資訊

### Useful Information

#### 一、新型專班產學獎助金與學生義務 INTENSE Program Industry-Academia Grants and Student Obligations

新型專班以 2 年培育期為原則，由於學生就學期間領取政府及企業獎助，畢業後即具有一定期間的留臺就業義務，參與企業具有優先留用聘僱學生的權利，以加速補足所需中高階人才。由行政院國家發展基金（下簡稱國發基金）提供產學獎助金，包含：

- 初次來臺相關必要行政費用、單程機票
- 最多 2 年學雜費，一學期補助上限為新臺幣 5 萬元

由合作企業提供：

- 每位學生每月至少新臺幣 1 萬元以上之生活津貼
- 實習期間不低於基本工資額度之實習津貼

領取國發基金產學獎助金的學生，依據領取年限具有相應留臺就業年限的義務。學生如中途退出專班或畢業後未履約就業者，若屬可歸責於學生之原因，應繳還產學獎助金。

◎前述新型專班資訊係節錄自教育部於 113 年 2 月 19 日公告之新型專班實施計畫（國家發展委員會 113 年 1 月 25 日修正版）。該計畫如經修正，將以教育部公告為準。

The INTENSE Program is designed for a duration of two years. As students receive government and corporate grants during their period of study, they are obligated to work in Taiwan for a certain period after graduation, while participating companies have the right to priority in retaining and hiring students, thereby accelerating the supplementation of much needed mid-to-high-level talents. The industry-academia grants are provided by the National Development Fund of the Executive Yuan (hereinafter referred to as the National Development Fund), and include the following:

- Necessary administrative expenses for the first arrival in Taiwan and a one-way plane ticket.
- Up to 2 years of tuition and miscellaneous fees, with a maximum of NT\$50,000 per semester.

In addition, the following is provided by participating companies:

- A living allowance of at least NT\$10,000 per student per month.
- An internship allowance equal of above minimum wage during the internship period.

Students receiving the National Development Fund's industry-academia grants are obligated to work in Taiwan for a corresponding number of years based on the duration of the grant received. If a student drops out of the program midway or fails to fulfill the employment requirements after graduation, and the reason is attributable to the student, they must pay back the received industry-academia grants.

◎The above information about the INTENSE Program is part of the INTENSE Program Implementation Plan announced by the Ministry of Education on February 19th, 2024 (previously revised by the National Development Council on January 25th, 2024). In the case of any amendments, announcements by the Ministry of Education shall take precedence.

### 輔仁大學外國籍學士與碩士新生獎學金

#### Fu Jen Catholic University Undergraduate and Master's Scholarships for New International Students

受獎期限為錄取當學期註冊後連續4學期，每學期獎學金金額為新臺幣1萬、3萬或5萬元整。每學期註冊後分5個月核發。

The scholarship is awarded for 4 consecutive semesters. The scholarship begins in the semester for which the recipient was granted admission and after the recipient has completed registration. The recipient will receive NT\$10,000, 30,000 or 50,000 per semester. The scholarship is disbursed in monthly installments after the recipient completes registration for the semester.

培育目標 Objectives	輔仁大學物理系教育與研究的目標為：擬定以光學為發展主軸之特色，特色為：光學薄膜和真空鍍膜技術等專業課程。許多科技產品需要真空鍍膜應用於表面處理。基於此，結合專業產業人才培育和本系教育與研究的目標，以及本系以發展光學為重點，整合了本系所資源，而規劃設計此「真空鍍膜技術專業產業人才培育學程」之特色課程。

本專班訓練學生具有真空鍍膜和光學薄膜技術能力，現有師資在真空鍍膜鍍膜與光學設計技術具有領先地位。注重實作的薄膜儀器教學，培養產業所需的光學技術能力，培養學生具有解決產業的問題，提升產業光學技術之能力。另外提供專班學生有機會去做產業相關的見習，培養實作能力，教導碩、博生獨立思考問題和解決問題並加強與業界合作。

本專班專業課程主要為真空鍍膜與、光學薄膜的設計、應用光學...等課程，利用薄膜厚度之多層光學薄膜結構，薄膜製鍍的方法、薄膜的特性...等，可以調整光入射的性質，產生光信號濾光特性。將來可應用於手機鏡頭、太空鏡片、半導體製程、隱形眼鏡設計、光通訊...等熱門領域。本專班學生必須著重實際操作各種不同的鍍膜機台，學習各種基板清潔、薄膜製鍍、光譜量測、薄膜光學參數量測...等，經由本專班訓練的學生學習的專業鍍膜與應用光學能力可以滿足科技業的就業市場需求。

In the Fu Jen Catholic University Physics Department, education and research is primarily aimed at optical development, with specialized courses in optical thin films and vacuum coating technology among others. As many technological products require vacuum coating applications for surface treatment, by combining the cultivation of professional industry talents with the objectives of our department's education and research, and focusing on the development of optics, we have integrated the resources of our department to plan and design the specialized curriculum of the 'INTENSE Vacuum Coating Technology Talent Cultivation Program.'

This program matches students with existing faculty leading in vacuum coating and optical design techniques to help them master vacuum coating and optical thin film technology: by emphasizing hands-on film instrument teaching, it cultivates the optical technology capabilities needed by the industry, trains students to solve industrial problems, and enhances the ability of industrial optical technology. Additionally, it offers students the opportunity to participate in internships within the industry to develop practical skills, simultaneously teaching master's and doctoral students to think and solve problems independently and strengthening cooperation with the industry.

The specialized courses offered by this program mainly include specialties such as vacuum coating, design of optical thin films, and applied optics, utilizing multi-layer optical thin film structures for film thickness, methods of film deposition, and film characteristics, to adjust the properties of incident light and produce optical signal filtering characteristics. Potential applications include smartphone lenses, space lenses, semiconductor processes, contact lens design, and optical communication in various popular fields. Students must focus on the practical operation of various coating machines and study various aspects such as substrate cleaning, film deposition, spectral measurement, and optical parameter measurement of films. After finishing this program, the professional coating and applied optics skills learned by students will make for a great match with the demand of the technology industry.
