The number of openings for international student admission listed for each degree program is based on the quota approved by Ministry of Education (MOE). If discrepancy exists between the data listed in this brochure and that stated in the MOE issued document, the data stated in the MOE issued document applies.

參、申請資格 Eligibility

以下條文節錄自教育部《外國學生來臺就學辦法》。辦法如經修正，將以教育部公告為準。其他申請資格相關規定請詳閱教育部《外國學生來臺就學辦法》。

The following articles are excerpted from the MOE Regulations Regarding International Students Undertaking Studies in Taiwan. If there have been any changes or updates to the regulations, the latest version announced by the MOE prevails. For other regulations related to eligibility, please refer to the MOE Regulations Regarding International Students Undertaking Studies in Taiwan.

第 2 條

具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依本辦法規定申請入學：

一、未曾以僑生身分在臺就學。

二、未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

Article 2

A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:

1. The person has never undertaken studies in Taiwan as an overseas Chinese student.

2. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

具外國國籍並符合下列規定，且最近連續居留海外六年以上者，亦得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上：

一、申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

二、申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

三、前二款均應符合前項第一款及第二款規定。

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

1. A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.

2. A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.

3. A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

（省略第三項 Paragraph 3 is omitted）

第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

一、就讀僑務主管機關舉辦之海外青年技術訓練班或教育部（以下簡稱本部）認定之技術訓練專班。

二、就讀本部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

三、交換學生，其交換期間合計未滿二年。

四、經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

具外國國籍並兼具中華民國國籍，且於本辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

The term “overseas” used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

1. attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;
2. spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
3. spent a total period of less than two years in Taiwan as an exchange student; or
4. spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.

A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to these Regulations may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

第 3 條

具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上。

Article 3

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

前項所稱連續居留，指每曆年在國內停留期間，合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。

The term “resided [...] continuously” in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph.

曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上。

A person who was formerly from the Mainland Area and who has foreign nationality and has have never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

前項所稱連續居留，指每曆年在國內停留期間，合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外連續居留期間計算。

The term “resided [...] continuously” in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period that they resided continuously overseas referred to in the previous paragraph.

第一項及第三項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。
The periods of six years and eight years stipulated in Paragraph 1 and in Paragraph 3 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

第一項至第四項所定海外，準用前條第五項規定。
The definition of “overseas” given in Paragraph 5 of the previous article also applies, mutatis mutandis, to Paragraphs 1 to 4.

第 4 條

外國學生依前二條規定申請來臺就學，以一次為限；其繼續在臺就學者，入學方式應與我國內一般學生相同。但下列情形，不在此限：

- 一、於完成申請就學學校學程後，申請碩士班以上學程，逕依各校規定辦理。
- 二、外國學生申請來臺就讀學士班以下學程，在國內停留未滿一年，因故退學或喪失學籍，得重新申請來臺就學，並以一次為限。

Article 4

An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. If a student wants to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students. However, this requirement does not apply to an international student in either of the following circumstances:

1. If an international student is applying for admission to a master's degree or higher level program after completing the course of study at the educational institution to which they originally applied, the university to which the student is now applying shall handle the application in accordance with its regulations;
2. If an international student applied to come to Taiwan to undertake a bachelor's degree or lower-level program in Taiwan and after coming to Taiwan stayed for less than one year for some reason then discontinued their studies or forfeited their student status, that student may lodge another application to come to Taiwan to study, but only one such re-application is permitted.

外國學生經入學學校以操行或學業成績不及格、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前項規定申請入學。

If an educational institution in Taiwan where an international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous paragraph.

學歷資格：

Education qualification:

1. 學歷資格須符合教育部《外國學生來臺就學辦法》、《大學辦理國外學歷採認辦法》、《香港澳門學歷檢覈及採認辦法》、《大陸地區學歷採認辦法》及《入學大學同等學力認定標準》之規定。

You may apply if you meet the requirements specified in MOE Regulations Regarding International Students Undertaking Studies in Taiwan, Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education, Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao, Regulations Governing the Recognition of Educational Qualifications from Mainland China, and Standards for Recognition of Equivalent Educational Levels for University Admission.

2. 申請學士班者須具國外高中畢業學歷、申請碩士班者須具大學畢業學歷、申請博士班者須具碩士畢業學歷。

Applicants who have graduated from a high school, college or university recognized by the Ministry of Education (R.O.C.) may apply for admission. International students with a high school diploma are eligible to apply for undergraduate programs; bachelor's degree holders for Master's programs; Master's degree holders for Doctoral programs.

備註：中華民國《國籍法》第二條：

有下列各款情形之一者，屬中華民國國籍：

- 一、出生時父或母為中華民國國民。
- 二、出生於父或母死亡後，其父或母死亡時為中華民國國民。
- 三、出生於中華民國領域內，父母均無可考，或均無國籍者。
- 四、歸化者。

前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

Note: Article 2 of the **Nationality Act** states:

A person shall have the nationality of the R.O.C. under any of the conditions below:

1. His/her father or mother was a national of the R.O.C. when he/she was born.
2. He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the R.O.C. at the time of death.
3. He/she was born in the territory of the R.O.C., and his/her parents cannot be ascertained or both were stateless persons.
4. He/she has undergone the naturalization process.

Subparagraphs 1 and 2 above also apply to persons who were minors at the time when this Act was amended and promulgated.

二、申請費 Application Fee

1. 國內匯款者，每一申請件新台幣1,600元；海外匯款者，每一申請件美金65元。申請費一經繳納，恕不退還。

The application fee is NT\$1,600 per program if you are applying from within Taiwan. If you are applying from a location overseas, please pay an application fee of US\$65 per program. Please note that application fees will not be refunded.

2. 請自申請系統下載專屬匯款資訊。請勿連同其他申請者費用一起匯款，以免資料無法核對。
Download the remittance information for your exclusive account from the online application system. Please only pay your own application fee(s). Do not combine your payments with other applicants because the university may not be able to confirm that you paid.
3. 申請費收據須於申請期間內上傳至申請系統。
Upload a scanned copy of your payment receipt to the system by the application deadline.

三、申請文件 Required Documents

- ◎ 若有疑義，本校得要求申請者繳交經我國駐外機構驗證之文件，並經駐外機構查證後，方可核發入學許可。

If there are any points of uncertainty, the University may request that the documents be authenticated by an overseas representative office of the Republic of China (Taiwan). The University will only issue a Certificate of Admission after successful verification by the representative office.

1. 在臺灣就讀的大學所開立之當學期在學證明

Certificate of enrollment which can prove that the applicant is currently studying at present semester in other universities in Taiwan.

2. 歷年成績單，須有至少 1-2 個學期以上成績

The official transcript, candidates must have an official transcript of course grades for at least one or two semesters.

A. 大陸地區學歷：應依《大陸地區學歷採認辦法》規定辦理。

Academic credentials earned in mainland China should be handled in accordance with [Regulations Governing the Recognition of Educational Qualifications from Mainland China](#).

B. 香港或澳門學歷：應依《香港澳門學歷檢覈及採認辦法》規定辦理。

Academic credentials earned in Hong Kong or Macao should be handled in accordance with [Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao](#).

C. 其他地區學歷：

(1) 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

(2) 前二目以外之國外地區學歷，應依《大學辦理國外學歷採認辦法》規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

Academic credentials earned in other areas:

(1) Academic credentials earned at overseas Taiwan schools or Taiwan schools in mainland China will be regarded as equivalent to credentials earned at domestic schools.

(2) Academic credentials other than the two items mentioned above will be handled in accordance with [Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education](#). However, academic credentials earned from a foreign academic institute or university branch established in mainland China must be notarized in mainland China, then examined and verified by an agency established or appointed by the Executive Yuan, or through a private agency commissioned by the Executive Yuan.

3. 最近三個月內由金融機構開立足夠在臺就學之財力證明（依申請系所之學期學雜費基準，檢附相當於新臺幣二十萬元(含)以上之財力證明），或政府、本校或民間機構提供全額獎助學金之證明（中、英文以外之語文，應加附經公證之中文或英文譯本）。財力證明不得由代辦、公司行號或個人開立

Financial proof issued within the last 3 months by a banking institution, demonstrating financial sustainability for study in Taiwan (equivalent to TWD\$200,000 or more, based on the stipulated tuition and fees of the relevant department or institute to which the student is applying), or official proof of a full scholarship provided by a government agency, university, college, or private organization, must be submitted; if the original document is in a language other than Chinese or English, a notarized translation in Chinese or English is required, and the financial proof **MUST NOT** be issued by agents, companies, or individuals.

4. 申請費收據

Receipt for application fee

5. 國籍證件（例如：護照）

Verification of nationality (e.g. a photocopy of your passport)

6. 切結書（自申請系統下載列印，簽名後再上傳）

Declaration Form (Download the form from the application system, complete it, and then upload it back to the system.)

7. 系所指定之其他文件（詳見系所分則）

Additional documents required by the department or graduate program you are applying to (Please refer to **Individual Requirements**.)

8. 視個案情況，本校得要求申請者檢附其他證明文件以審核其申請資格與學歷，例如：入出國日期證明書、未設戶籍切結書、香港或澳門永久居留資格證明、父母親中華民國身分證件、喪失國籍許可證書等等。

Depending on the circumstances, the University may request additional documents to review your eligibility and educational background, such as the Certificate of Entry and Exit Dates, Non-Household Registration Declaration Form, a proof of the permanent residence status in Hong Kong or Macao, a document that proves your father or mother has/had R.O.C. nationality status, the Certificate of Nationality Annulment, and so on.

伍、公告錄取名單、寄發入學許可

2. 入學許可將寄送至申請者於申請系統填寫之通訊郵寄地址。

FJCU will send the Certificate of Admission to the mailing address provided in your online application.

3. 入學許可並不保證簽證取得，簽證須由我國外交部領事事務局或駐外機構核給。

The Certificate of Admission does not guarantee the issuance a visa. Visas must be granted by the Bureau of Consular Affairs or by an overseas representative office of the Republic of China (Taiwan).

陸、回覆入學意願

Submitting the Intent to Enroll

一、正取生 Accepted Applicants

- 於申請系統完成入學意願回覆並獲錄取資格者，本校將寄發入學許可。
After you have submitted the Intent to Enroll in the application system, the University will mail your Certificate of Admission.
- 未於期限內線上回覆入學意願者，視為放棄錄取資格。所遺缺額由備取生依規定遞補。
If you do not submit the Intent to Enroll online by the deadline, FJCU will consider you as voluntarily declining the offer of admission. Your spot will be offered to a student on the waiting list.

二、備取生 Waitlisted Applicants

1. 通知方式：依當時缺額狀況，以電子郵件通知遞補。
Results will be sent by email according to the status of vacancies.
2. 於申請系統完成入學意願回覆並獲錄取資格者，本校將寄發入學許可。
After you have submitted the Intent to Enroll in the application system, the University will mail your Certificate of Admission.

- 一、 本規定依據教育部「外國學生來臺就學辦法」第六條規定訂定之。
- 二、 具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依本規定申請入學：

(一) 未曾以僑生身分在臺就學。

(二) 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

具外國國籍並符合下列規定，且最近連續居留海外六年以上者，亦得依本規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上：

(一) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

(二) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

(三) 前二款均應符合前項第一款及第二款規定。

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定之限制。

第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間合計未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

(一) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

(二) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

(三) 交換學生，其交換期間合計未滿二年。

(四) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

具外國國籍並兼具中華民國國籍，且於教育部外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

具有國籍法第二條規定情形者，為本規定所定具有中華民國國籍。

三、具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上。

前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合前點第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。

曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上。前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合前點第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外連續居留期間計算。

第一項及第三項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

第一項至第四項所定海外，準用前點第五項規定。

四、外國學生依前二點規定申請來臺就學，以一次為限；繼續在臺就學者，入學方式應與我國內一般學生相同。

外國學生有下列情形之一者，其於前項申請後，復申請繼續在臺就學，或再次申請來臺就學，不受前項規定之限制：

(一) 於完成申請就學學校學程後，申請碩士班以上學程，逕依本校規定辦理。

(二) 外國學生申請來臺就讀學士班以下學程，在國內停留未滿一年，因故退學或喪失學籍，得重新申請來臺就學，並以一次為限。

(三) 符合第二點第一項規定之外國學生，申請入學大學醫學、牙醫或中醫學系以外之學士班學程，並以一次為限。

外國學生經入學學校以操行不及格或學業考核未達規定、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前二項規定申請入學。

五、本校實際招收入學之外國學生，其名額以教育部核定本校前一學年度招生名額外加百分之十為原則，並應併入當學年度招生總名額報教育部核定。申請招收外國學生名額超過前一學年

度核定招生名額外加百分之十者，應併同提出增量計畫（包括品質控管策略及配套措施）報教育部核定。但本校與外國大學合作並經教育部專案核定之學位專班，不在此限。

本校於前一學年度核定招生總名額內，有本國學生未招足情形者，得以外國學生名額補足，並應報教育部核定。

第一項招生名額，不包括未具正式學籍之外國學生。

- 六、本校招收外國學生入學各年級，依本規定訂定外國學生招生簡章，詳列招生方式、入學資格審查程序、招生系所、各招生系所授課語言、學生應具備之語文能力基準、修業年限、招生名額、申請資格、財力證明基準、學雜費收退費基準、學校獎助學金資訊及其他相關事項。本校招生方式包含但不限於公告招生資訊於本校或政府網站，及參加海外教育展宣傳等。本校辦理外國學生招生事務，除宣傳推廣及協助學生辦理來臺相關必要程序外，不得委由校外機構、法人、團體或個人辦理；並應適時確認其是否向外國學生收取不合理之費用、成立借貸關係或其他違反相關法令之情形，必要時得向申請之外國學生查核。

本校自行或委由校外機構、法人、團體或個人辦理外國學生招生相關事項，不得提供與招生規定、招生簡章或相關規定不一致之資訊。

- 七、符合申請資格規定者，應於每年簡章規定受理期間，檢附下列文件向本校申請入學，經審查或甄試合格者，發給入學許可：

（一）入學申請表。

（二）學歷證明文件：

1. 大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。

2. 香港或澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。

3. 其他地區學歷：

（1）海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

（2）前二目以外之國外地區學歷，應依大學辦理國外學歷採認辦法規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

（三）足夠在臺就學之財力證明（依申請系所之學期學雜費基準，檢附相當於新臺幣二十萬元(含)以上之財力證明），或政府、本校或民間機構提供全額獎助學金之證明。

（四）本校規定或系所指定之其他文件。

（五）語文能力證明：

1. 申請需具中文能力之系所（以下擇一）：

（1）檢附華語文能力測驗（TOCFL）A2（含）以上等級之證明或相當等級之國際通用中文能力證明。

（2）前一學位為中文授課，提供學校開立證明。

2. 申請需具英文能力(包含有足夠英文授課課程可滿足畢業需求)之系所(以下擇一)：

(1)檢附相當於歐洲共同語文參考架構（CEFR）B1等級之英文能力證明。

(2)前一學位為全英語授課，提供學校開立證明。

各招生系所得指定更高等級或其他外語之語文能力證明。

(六) 申請費。

本校審核外國學生之入學申請時，對前項第二款至第五款未經我國駐外機構、行政院設立或指定之機構或委託之民間團體驗證之文件認定有疑義時，得要求經驗證；其業經驗證者，得請求協助查證。

外國學生之入學申請由本校國際及兩岸教育處受理並初審申請文件是否齊全；初審合格件，送交各招生系所依其訂定之入學標準複審；複審合格名單經校級會議審議通過後，由本校教務處發給入學許可予獲錄取資格並完成入學意願回覆者。

第一項入學許可應載明外國學生之姓名、就讀學程名稱、學位別、授課語言、入學之學年、學期開始日期、學雜費收退費基準、獎助學金及其他應告知外國學生之相關資訊之中文及英文版本，確認外國學生瞭解來臺就學相關權利義務，並得提供外國學生母國語言版本。

八、 外國學生所繳入學證明文件有偽造、假借、塗改等情事，應撤銷錄取資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明；如畢業後始發現者，由本校撤銷其畢業資格並註銷其學位證書。

九、 外國學生已在臺完成學士以上學位，繼續申請入學碩士以上學程者，得檢具我國各校院畢業證書及歷年成績證明文件，依第七點規定申請入學，免檢附第七點第一項第二款規定之境外學歷證明文件。

符合第二點第一項規定之外國學生，在我國完成副學士以下學程者，得持該學歷證明文件及歷年成績證明文件，依第七點規定申請入學學士班，免檢附第七點第一項第二款規定之境外學歷證明文件。

十、 本校註冊入學之外國學生資料，應即時於教育部指定之外國學生資料管理資訊系統，登錄外國學生錄取、入學、轉學、休學、退學或變更、喪失學生身分、離境等情事。

十一、 外國學生不得申請就讀本校所辦理回流教育之進修學士班、碩士在職專班及其他僅於夜間、例假日授課之班別。但外國學生在臺已具有合法居留身分者或其就讀之班別屬本校經教育部專案核准之課程者，不在此限。

十二、 經核准入學之外國學生註冊入學時，未逾該學年第一學期修業期間三分之一者，於當學期入學；已逾該學年第一學期修業期間三分之一者，於第二學期或下一學年註冊入學。但教育部另有規定者，不在此限。

十三、 外國學生於本校畢業後，經本校核轉教育部許可在我國實習者，其外國學生身分最長得延長至畢業後一年。

外國學生在本校就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。但符合下列情形之一者，不在此限：

(一) 入學方式與我國內一般學生相同。

(二) 依國籍法第四條第一項第一款至第三款申請歸化取得中華民國國籍者。

(三) 符合第二點第一項規定且依國籍法第三條至第七條申請歸化取得中華民國國籍。

於我國大專校院就讀之外國學生轉學，依本校學則、本規定及當年度外國學生申請入學招生簡章規定辦理。但外國學生經入學學校以操行不及格或因刑事案件經判刑確定致遭退學者，不得轉學進入本校就讀。

十四、 本校在不影響正常教學情況下，得與外國學校簽訂教育合作協議，招收外國交換學生；並得準用外國學生入學規定，酌收外國人士為選讀生。

十五、 本校因國際學術合作計畫或其他特殊需求需成立外國學生專班者，應依專科以上學校總量發展規模與資源條件標準相關規定，報教育部核定。

十六、 本校為鼓勵外國學生來臺就學，得設置外國學生獎學金、助學金。

十七、 外國學生就學應繳之費用，依下列規定辦理：

(一) 經駐外機構推薦來臺就學之外交部臺灣獎學金受獎學生及具我國永久居留身分者，依本校所定我國學生收費基準辦理。

(二) 依教育合作協議入學者，依協議規定辦理。

(三) 前二款以外之外國學生，依本校所定外國學生收費基準辦理。

十八、 外國學生註冊時，新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險，在校生應檢附我國全民健康保險等相關保險證明文件。如未投保者，應於註冊時繳納保險費，由本校代辦投保事宜。

前項保險證明如為國外所核發者，應經駐外機構驗證。

十九、 外國學生之學業輔導由所屬系所辦理；其生活輔導與保險事宜則由學生事務處與國際及兩岸教育處辦理。

外國學生有違反就業服務法之規定經查證屬實者，本校應即依規定處理。

二十、 外國學生如有休、退學或變更、喪失學生身分等情事，本校應通報外交部領事事務局及本校所在地之內政部移民署服務站，並副知教育部。

二十一、 外國學生來臺於本校附設之華語文中心學習語文者，其申請程序、獎補助、管理與輔導、缺課時數逾該期上課總時數四分之一以上及變更或喪失學生身分之通報，準用第七點第一項第一款、第三款至第五款、第十點、第十六點、第十八點、第十九點及第二十點規定。

二十二、 外國學生申請入學除適用本規定外，並依教育部及本校有關法令規定辦理。

二十三、 本規定經校級招生委員會議通過，報請教育部核定後施行。修正時亦同。

Article 1 The following Regulations are established in accordance with Article 6 of the “Regulations Regarding International Students Undertaking Studies in Taiwan,” issued by the Ministry of Education (MOE).

Article 2 An individual of foreign nationality, who has never held nationality status from the Republic of China (ROC), and meets the following criteria is qualified to apply for admission under this regulation:

1. has never studied in Taiwan as an overseas Chinese student.
2. has not been given a placement to study in an academic institution in Taiwan via the University Entrance Committee for Overseas Chinese Students under the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan during the year of their application.

An individual of foreign nationality who meets the following requirements and who has resided overseas continuously for the most recent 6 years is also qualified to apply for admission under this regulation. However, an individual who plans to apply for study at a department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for no less than 8 years.

1. An individual who also is a national of the ROC, but does not hold or has had a household registration in Taiwan.
2. An individual who also was a national of the ROC but has no ROC nationality at the time of their application shall have an annulled status regarding their ROC nationality for no less than 8 years after an annulment of ROC nationality by the Ministry of the Interior.
3. Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor been given a placement through the University Entrance Committee for Overseas Chinese Students during the same year as making the application.

According to the Education Cooperation Framework Agreement, a foreign national who was selected by a foreign government, organization, or school, and does not hold a household registration from the time of their birth is not subject to the limitations as prescribed in the preceding 2 paragraphs after receiving the approval from MOE.

The six-year and eight-year calculation period as prescribed in Paragraph 2 shall be calculated

from the starting date of the semester (February 1 or August 1) as the designated due date for the time of study.

The term “overseas” as prescribed in Paragraph 2 is limited to countries or regions other than Mainland China, Hong Kong, and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. If the calculated calendar year is not one complete calendar year, their stay in Taiwan should not exceed 120 days within the calculated calendar year period. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supported proof:

1. Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by MOE;
2. Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by MOE, and to which the total length of stay is less than 2 years;
3. Exchange students, whose length of total exchange is less than 2 years; or
4. An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

An individual, who has both foreign and ROC nationalities and has applied for an annulment of their ROC nationality before February 1, 2011, the effective date of this amendment, will then be qualified to apply for admission as an international student under the amendment effective before February 1, 2011, and will not be subject to the limitation as prescribed in Paragraph 2.

For the purposes of these Regulations, individuals who meet the conditions prescribed in Article 2 of the Nationality Act shall be deemed nationals of the ROC.

Article 3

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission under these regulations. However, an individual who plans to apply for study at a department of medicine, dentistry, or Chinese medicine must reside overseas continuously for no less than 8 years.

The term “reside overseas continuously” mentioned in the preceding paragraph means an individual may stay in Taiwan for no more than a total of 120 days per calendar year. However, such a term may be exempt, if any of the conditions prescribed in Subparagraphs 1 through 4, Paragraph 5 of the previous article applies and is supported with written proof, and the said domestic length of stay shall be excluded from the overseas length of residency.

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission under these regulations. However, an individual who plans to apply for study at a department of medicine, dentistry, or Chinese medicine must reside overseas continuously for no less than 8 years.

The term “reside overseas continuously” means an individual may stay in Taiwan for no more than a total of 120 days per calendar year. However, such a term may be exempted if any of the conditions prescribed in Subparagraphs 1 through 4, of Paragraph 5 of the previous article, applies and is supported with written proof, and the said domestic length of stay shall be excluded from the overseas length of residency.

The six-year and eight-year calculation period as prescribed in Paragraph 1 and Paragraph 3 shall be calculated from the starting date of the semester (February 1 or August 1) as the designated due date for the time of study.

The term overseas as prescribed in Paragraph 5 in the previous article shall apply to Paragraphs 1 to 4.

Article 4

International students applying to study in Taiwan in accordance with the preceding two articles may do so only once. Continuation of studies in Taiwan shall be handled in a manner

identical to the admission procedures for local students.

International students who meet any of the following conditions shall not be subject to the restrictions stipulated in the preceding paragraph when, after submitting a previous application, they apply to continue their studies in Taiwan or reapply for admission to study in Taiwan.

1. Application to study for a master's degree or higher levels of graduate studies shall be handled in accordance with FJCU regulations.
2. For international students applying to take an undergraduate course or lower levels of study, if the duration of their stay in Taiwan is less than a year, and if they were to drop out from school or lose their student status, they may reapply to study in Taiwan for a maximum of one time.
3. International students who meet the conditions set forth in Article 2, Paragraph 1 may apply for admission to an undergraduate program other than those in medicine, dentistry, or Chinese medicine, and such application shall be limited to one time only.

International students who have been expelled or have lost student status due to misconduct, unsatisfactory academic performance, or violation of laws or school rules and regulations, shall not be allowed to reapply to the school under the provisions stipulated in the preceding two paragraphs of this article.

Article 5

The actual number of international students recruited and enrolled at FJCU must in principle not be more than an additional ten percent above the total admission quota for the previous academic year. The number should be calculated into the total number of positions at FJCU yearly and reported to MOE for ratification. If the number of international students applying for admission to FJCU for an academic year exceeds more than ten percent above the total admission quota of the previous academic year, FJCU must submit a plan for the increased number (which include quality control strategies and supporting measures) to MOE for approval. Degree programs offered by FJCU and collaborating foreign universities that have been approved on a case-by-case basis by MOE are not subject to this restriction.

If the quotas for admission for the previous academic year, which have been allocated for local students, have not been filled, FJCU may give the quotas to international students, and submit the figures to MOE for approval.

The admission quota prescribed in Paragraph 1 does not include international students with a non-degree status.

Article 6

Pursuant to these regulations, when recruiting and accepting international students across all educational levels, FJCU makes a brochure for enrollment of international students which clearly set forth the enrollment method, admission eligibility procedures, the departments and graduate programs that recruit international students, the language of instruction of each recruiting department, language proficiency requirements, the duration of study, admission quotas, rules related to eligibility for application, requirements for financial statements, regulations regarding tuition and fees, information on scholarships, and other relevant admission requirements.

The enrollment methods of FJCU include, but are not limited to, posting enrollment information on the University's or the government's website, and participating in overseas education fairs. With the exception of publicity, promotion and assisting students to complete the necessary procedures for coming to Taiwan, FJCU shall not delegate enrollment of international students to outside organizations, corporations, groups or individuals. In addition, FJCU shall verify in a timely manner whether it has collected unjustified fees from international students, established lending relationships, or otherwise violated relevant laws and regulations, and may, if necessary, request clarification from students who have applied for admission.

FJCU shall not provide any information that is inconsistent with the enrollment regulations, enrollment brochures, or related regulations when handling matters related to the enrollment of international students on its own or through an external agency, corporation, organization,

or individual.

Article 7 Qualified applicants are required to submit formal applications with the following documents to FJCU during the application period stipulated in the statement of regulations issued every year. Those who pass the evaluation or examination will be allowed to enroll in FJCU.

1. Application form.

2. Academic credentials:

(1) Academic credentials from Mainland China: The Regulations Governing the Accreditation of Schools in Mainland China shall apply.

(2) Academic credentials from Hong Kong or Macao: Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macao shall apply.

(3) Academic credentials from other areas:

A. Academic credentials earned at overseas Taiwan schools or Taiwan schools in Mainland China shall be regarded as the same as those at domestic schools with equivalent levels.

B. Academic credentials referred to the preceding 2 items shall be subject to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials earned from institutes or branches established in Mainland China by foreign schools shall require public notarization in Mainland China and be verified and examined by an institute established or appointed by, or through a private agency commissioned by the Executive Yuan.

3. Financial proof that shows financial sustainability for study in Taiwan (equivalent to at least NT\$200,000 based on the stipulated tuition and fees of the relevant department or institute to which the student is applying), or proof of full scholarship provided by a government agency, university, college, or private organization.

4. Additional documents and materials required by the intended departments, graduate programs, or the university.

5. Proof of language proficiency:

(1) For departments requiring Chinese language proficiency, either of the following is required:

A. A certificate of the Test of Chinese as a Foreign Language (TOCFL) of level A2 or above, or an internationally accepted certificate of an equivalent level.

B. Applicants whose previous degree was taught in Chinese may instead submit an official certificate issued by the awarding institution.

(2) For departments requiring English language proficiency (including those offering sufficient English-taught courses to meet graduation requirements), either of the following is required:

A. An English language proficiency certificate equivalent to the Common European Framework of Reference for Languages (CEFR) level B1 or above.

B. Applicants whose previous degree was taught in English may instead submit an official certificate issued by the awarding institution.

Each department may specify a higher level or other foreign language proficiency certificate.

6. Application fee.

The university that reviews the application documents without verification by an overseas representative office, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, as prescribed in Subparagraphs 2 to 4 of the preceding paragraph may request for verification by an overseas agency. If the said documents have been verified, the school may request an examination of the documents.

The FJCU Office of International Education accepts applications from international students and conducts a preliminary review to determine if the provided documents are complete; those applications that pass the preliminary review are sent to the relevant departments for further review in accordance with their admission criteria. After the list of qualified applicants

has been reviewed and approved at the University Council, the Office of Academic Affairs will issue a Certificate of Admission to all applicants who have been admitted and have confirmed their intent to enroll. The Certificate of Admission prescribed in Paragraph 1 shall contain, in both Chinese and English, the name of the international student, the name of the program, the degree, the language of instruction, the academic year of admission, the start date of the first semester, the basic regulations regarding tuition and fee payment, information on scholarships, and other information relevant to international students, to confirm that the student understands the rights and obligations related to studying in Taiwan. The school may provide a version in the language of international student.

Article 8 An international student submitting forged, fabricated, or altered papers for the purpose of FJCU application shall be subject to enrollment qualification cancellation; or a revocation of enrollment and denial to the request of any certificate pertaining to study, if the said student is already enrolled; or revocation of graduation qualifications and cancellation of the diploma by the university, if the said student has been already graduated.

Article 9 An international student who has completed a bachelor's degree or a higher degree in Taiwan and applies for a master's program shall be exempt from submitting academic credentials from overseas as listed in Article 7, Paragraph 1, Subparagraph 2, provided that a graduation certification and transcript for each consecutive semester issued from the educational institutions in Taiwan shall be enclosed.

International students who meet the provisions set forth in Article 2, Paragraph 1, and who have completed an associate degree or a program below that level in Taiwan, may also apply for admission to an undergraduate program under Article 7 by submitting their academic certificates and official transcripts, and are exempt from the requirements listed in Article 7, Paragraph 1, Subparagraph 2.

Article 10 The university offering admission to international students shall promptly register into the international student data management information system designated by MOE the following: school admission, enrollment, transfer, suspension or dismissal, change or loss of student status, and departure.

Article 11 International students shall not apply for any recurrent educational programs that FJCU offers, which include the School of Continuing Education, In-service Master Programs, or other programs conducted only in the evenings or weekends and holidays, with the exceptions of students who obtain legal resident status in Taiwan, or who have enrolled in a program ratified by MOE.

Article 12 International students will be allowed to register for the first semester should the student's arrival time dates within one-third period of the first semester. International students will be allowed to register for the second semester or the next school year should the student's arrival dates over one-third period of the first semester. However, this restriction does not apply if MOE has some provision that overrides it.

Article 13 International students who have been approved for an internship by MOE after their graduation from FJCU may afterward extend their international student status for one year at most after graduation from the University.

During the course of study at FJCU, international students who are approved for initial household registration, resident registration, naturalization, or restoration of their ROC nationality, will lose their international student status and shall withdraw from FJCU.

However, students who meet any of the following conditions are exempt from this requirement:

1. The student is enrolled in the same manner as local students.
2. The student has acquired ROC nationality through naturalization in accordance with Article 4, Paragraph 1, Subparagraph 1 to 3 of the Nationality Act.
3. The student meets the provisions set forth in Article 2, Paragraph 1, and has acquired ROC nationality through naturalization in accordance with Articles 3 to 7 of the Nationality Act.

International students who plan to transfer to FJCU from a local tertiary institution shall follow

the academic regulations of FJCU, the Regulations Governing Admission of International Students, and the Admission Brochure for International Students of the current school year. However, an international student that has been dismissed by a school that accepts the said student, due to behavior issues or a conviction under the Criminal Law may not transfer to FJCU.

- Article 14 Without interfering with normal educational activities, FJCU may sign education cooperation agreements with foreign schools and recruit and accept international exchange students, and their admission standards for international students may be applied with respect to acceptance of international students as non-degree seeking auditing students.
- Article 15 When establishing a special program for international students based on an international academic cooperation plan or other special needs, FJCU must file an application with the MOE for ratification in accordance with the regulations regarding the Student Admission Quotas and Resources applicable to tertiary institutions, taking into consideration school developmental scale and resources.
- Article 16 In order to encourage international students to study in Taiwan, the university may establish scholarships or fellowships for international students.
- Article 17 All necessary expenses for international students during their course of study at FJCU are handled in accordance with the following regulations:
1. The scholarship awardees of the Ministry of the Foreign Affairs and students who possess an Alien Permanent Resident Certificate shall pay fees in accordance with the FJCU regulations pertaining to local students.
 2. Students enrolled under the Collaborative Education Agreement shall pay fees in accordance with the regulations stipulated in the agreement.
 3. International students not belonging to the above two categories shall pay fees in accordance with the FJCU regulations pertaining to international students.
- Article 18 Upon registration, the newly admitted international students should show a proof of insurance which includes both medical and accident coverage for a period of at least 6 months from the date of their arrival. Current students need to submit proof of their National Health Insurance. If not insured, international students shall pay the insurance fee at the time of registration. Matters regarding insurance will be handled by the university. The abovementioned written proof of insurance issued in a foreign country shall be verified by an overseas representative office.
- Article 19 International students' academic counseling is to be managed by the department or the graduate school that they belong to. Guidance for personal affairs and matters pertaining to insurance is to be handled by the Office of Student Affairs and the Office of International Education.
- The university shall immediately handle the cases in accordance with the regulations if international students violate the Employment Services Act after investigation.
- Article 20 If international students are expelled or suspended from FJCU, or if there is any change or loss of their student status, they shall be reported by FJCU to the Bureau of Consular Affairs of the Ministry of the Foreign Affairs, and the service center of the National Immigration Agency of the Ministry of the Interior where the university is located. The MOE shall also be notified.
- Article 21 International students who come to Taiwan to study language in the Center of Chinese Language and Culture affiliated with FJCU may be subject to the restrictions set forth in Subparagraph 1, 3 to 5 of Paragraph 1 in Article 7, and in Articles 10, 16, 18, 19 and 20 for matters pertaining to application procedures, aid and scholarships, management and counseling, and the reporting of absence for more than one-fourth of the total class hours of a semester, and change or loss of student status.
- Article 22 When applying for admission to FJCU, international students shall follow these regulations as well as other relevant rules and ordinances made by FJCU and the MOE.
- Article 23 The above regulations have been passed by the Admissions Council of the university, and will take effect after the approval of the MOE. The procedure is the same for revision.
